Historical Background Cont.

- 1862 Morrill Act Created 1862 land-grant universities
 - Public universities
 - This was during the time of segregation
 - These institutions were not open to all people



Historical Background Cont.

1890 Morrill Act – Expanded funding for the land-grant universities

- Stipulated that the institutions had to be open to all people to receive the funding
- This created a lot of debate because of resistance
- This led to the creation of the 1890 land-grant universities

Matching Requirements

1890s were required to match federal funding in:

1890 Matching Requirements

- In 1998 the universities were required to match federal funding at 50% level by 2002
- In 2002 the universities were required to match a dollar for dollar by 2007
 - All 1890 universities have not achieved the match
 - The Smith -Lever Act required the 1862 institutions to match a dollar for dollar initially
